### **Nursing Foundation Lab**

Nursing Foundation lab is a patient simulator. Nursing is an art and science that needs a lot of practice. The Nursing Foundation lab is the practical area of the students, where they perform all nursing procedures prior to the exposure to the clinical field. The faculty uses the lab for various demonstrations of procedures in nursing. This spacious laboratory is well equipped with patient simulator, cardio-pulmonary resuscitation mannequin, life form hand simulation, etc. in addition to the facilities in real ward situation.

## **Pre-Clinical Science Lab**

Clinical laboratory scientists are responsible for the performance of routine and specialized tests in the clinical laboratory. They are educated to correlate test results with the physiological condition of patients. Physicians utilize these results to determine the diagnosis, prognosis, and treatment of disease. Clinical laboratory scientists are responsible for the performance of routine and specialized tests in the clinical laboratory. They are educated to correlate test results with the physiological condition of patients. In addition to hospitals, clinical laboratory scientists may be employed in veterinary schools and clinics, research, reference laboratories, physician offices, industry, and biotechnology companies.

### **Nutrition Lab**

Nutrition laboratory is primarily focused on assessing the inter play between diet and cardiovascular and other disease risk factors. Lifestyle behaviors, especially diet, can have a significant effect on the risk of developing heart disease. Major components of diet that can potentially alter his risk include type of fat, level of fat, type of protein, individual fatty acids and food-associated compounds. The efforts of the nutrition lab are aimed at developing a better understanding of how diet alters cardiovascular and other disease risk factors, especially in other women and men. The Nutrition laboratory is where the students learn to prepare normal and therapeutic diet. Students learn to prepare different types of exhibits for health education related to Nutrition and diet therapy.

#### **A.V. Aids Rooms**

Bharathi Group of Institutions has Audio Visual Aid Room is available for students to create their own audio visual aids. Laboratory is equipped with extensive audiovisual equipment to assist in the presentation through, LCD Projector, Slide projector, Film Projector, Video and 35 mm slide images to television, over-head Projector & Epidiascope allows active demonstrations, text or diagrams to be displayed. ## **RULES AND REGULATION**

eeping in view the aims and aspiration of **Bharathi Group of Institutions** certain rules and regulations have been framed to be strictly followed by trainees. These rules have been formulated not to bind the trainees within the premises but to make them understand the value and standard of discipline, which, when, followed meticulously by the trainees, help them to emerge into a more determined, matured and knowledgeable individual. A full hearted support from our trainees and guardians are thus solicited.


- 1. Students shall strictly comply with the rules and regulations of the college issued from time to time relating to their studies, examination, conduct and discipline.
- The student, who secure admission on the basis of false certificate / marks sheet or on the basis of any misrepresenting of facts or illegal means, shall be summarily cancelled and all fees paid by him/her shall be forfeited. Legal action shall also be taken against them.
- 3. Candidates are required to enclose along with their application, the affidavit before a Notary Public stating that all information given by them is
- 4. Application accompanied with requisite documents/enclosure receive after the last date shall be summarily rejected.
- 5. No refund of fees will be made on withdrawal of admission under any circumstances.
- 6. In case the candidate fails to submit the required documents, admission shall be treated as cancelled and no request for refund of fees will be entertained under any circumstances.
- 7. If the applicant is employed, employers no objection certificate with two year must be submitted during the time of admission.
- 8. Trainees can avail BGI's facilities only after the course commences and only till the course is running.
- 9. Trainees are liable to security checks on entry or exit from the college premises.
- 10. BGI will not be responsible for any loss of belonging left unattended by the trainees at the college premises.
- Intake of any sort of intoxicating substance is strictly prohibited. Chewing of Paan / Gutka / Chewing Gum is also prohibited.
- 12. A trainee has to ensure at least 80% attendance for attaining eligibility for appearing in any examination.
- 13. A medical certificate will be required if there are more than three days consecutive absence owing to illness.

Any damage or pilferage caused to BGI properties by any trainee will be appropriately charged for all deducted from the Caution Deposit Money (if any).
  - 15. Trainees should strictly adhere to instructions regarding entry/exit regulations, parking of vehicles etc. They should not bring friends, visitors or relatives to the class rooms or practical rooms.
  - Ragging is banned in BGI and any one indulging in ragging process is likely to be punished appropriately.
  - 17. Use of mobile is strictly prohibited in the Campus Area.
  - 18. All trainees are supposed to attend the classes in proper uniform suited for a gentleman / woman and as guided by BGI
  - 19. Male trainees must have short and properly groomed hair, clean and well trimmed nails. They should attend classes every day with a clean shave and polished shoe.
  - 20. Female trainees must have properly groomed hair, clean and well trimmed nails without nail polish. Perfumes should not be used while attending theory or practical classes.
  - 21. During class hours wearing the college Identity Card is compulsory.
  - 22. These rules come into effect immediately and equally apply on all trainees of BGI.
  - 23. BGI holds the right to introduce, alter, amend or change any or all the rules from time to time if found necessary.
  - 24. Interpretation of these rules will always be made by the designated persons of BGI and shall be final and binding on all trainees.
  - 25. For any legal dispute the jurisdiction will be at Ranchi Court only.

#### 26. Discontinuance:

- (i) In case any trainee is found not paying his/her fees within 15 days from the due date he/she will fetch strong disciplinary measures leading to discontinuance.
- (ii) If any trainees at their own opt to drop out from the course then the case will also be treated as discontinuance, in such a situation the course fee and other charges already paid will not be refunded under any circumstances.
- (iii) In case of absence for 15 consecutive days, the college must be informed of valid reason or the case will be treated as discontinuance.
- (iv) In case of misconduct and violation of college norms, trainees may fetch disciplinary action leading to discontinuance.
